



Project Cycle Management is a method through which defining common management activities and decisions-making procedures used during the project life cycle




The purpose of PCM is to do the right thing at the right moment

PROJECT CYCLE MANAGEMENT




Which are the key phases of the Project Cycle? How many are they? What belongs to each?








INDICATIVE PROGRAMMING ANSWERS THE NEED TO CLARIFY

For which aspects is it relevant?





A Common Thematic Framework


1. A Common Thematic Framework (CTF)builds on the capacity to interrelate the different needs and experiences tied to the theme

2. It should be sufficiently INCLUSIVE to allow each partner to identify itself with it, and sufficiently EXCLUSIVE to avoid a too broad and generic focus on the theme

LOCAL FEEDBACK (POLITICAL REPRESENTATIVES AND RELEVANT CIVIL SERVANTS) 1-5 1. How relevant is the theme to the local political agenda. Why? 2. What political commitment and participation will be ensured, by whom, and in what form? 3. To what extent is the organization informed and aware regarding what this EU funded initiative implies? 4. What further information and knowledge would it require? 5. Has the central issue been properly focussed by the project group?

Who should be consulted and/or involved? Who could benefit?



TOGETHER WITH WHOM? VERIFICATION AT LOCAL LEVEL

A) Who are the local stakeholders? Who could effectively participate and contribute to the project?



B) Are the stakeholders identified suitable with each other for the coherent development of the project?

STAKEHOLDERS INTERESTS AND EXPECTATIONS

Interests and expectations: crucial elements around which building committment:

What's in it for them? What are the benefits?

What are the interests that might conflict with the project?

What are the relations between stakeholders?

To what extent are they willing to committ? (resources)

Key elements!

To understand stakeholders perception and their point of view To avoid forgetting important aspects for them involved stakeholders



PRE-CONDITIONS OF IDENTIFICATION

General knowledge about the funding programme and the type of project

The theme is in line with the local political agenda

The theme is relevant for the stakeholders

THE IDENTIFICATION PHASE SERVES THE NEED

- TO FOCUS ON THE CENTRAL PROBLEM
 TO BE TACKLED
 - TO RELATE AND ANALYZE
 THE DIFFERENT CAUSES
 OF THE PROBLEM(S)
 - TO DESIGN A COHERENT NEED-DRIVEN STRATEGY
- = Logical Framework Methodology (LFM)

NEW PROJECT PROPOSALS METHODOLOGY

As **from January 2018**, new proposals from **project promoters** in SERN are collected ONLY in three specific moments during the year:

FIRST SLOT	15 January-15 February
SECOND SLOT	1 June – 30 June
THIRD SLOT	15 October – 15 November

If the minimum number of organizations is not archived (3 organizations) by the time of the **following slot** the proposal will not be considered for further discussion.

STEP BY STEP PROJECT PROPOSALS

Step 1: Fill in the "Partner Search" form provided by the SERN secretariat or download it from the SERN website.

Step 2: Send the Partner search form duly filled to the email address secretariat@sern.eu during one of the time slots indicated above

Step 3: The partner search form is circulated first of all among the SERN members and, if necessary, outside the network.

Step 4: After the partners have been identified and have accepted to participate, the organisation promoting the project proposal is responsible for the application process



WHAT HAPPENS NEXT?


THE FORMULATION

Option 1) The promoter or one of the partner formulates the project together with the other partners

The secretariat provides a review at the end of the formulation phase.

Option 2) The Secretariat supports the applicant in the formulation of the project (at extra cost).

TRAINING ACTIVITIES



The Secretariat (upon request of the members) organizes dedicated training sessions of 1-2 days module on Indicative Programming and Identification.



From the Autumn 2018 an additional module on Erasmus+
