ABOUT THE COURSE

The course runs over 5 half days, in the morning from 9 am (approximately 13 hours of teaching) and covers, as well as deepens, different areas such as EU and global environmental standards, environmental quality management, circular economy, history of renewable energy technique, environmental law from an EU perspective, global climate issue, the 17 SDGs, teaching pedagogics, energy audits along with theoretical and practical knowledge on how to organise, perform and evaluate environmental audits in a Synergy Audit way where different knowledge areas come together.

Teaching will be a mix of lectures, workshops and seminars given by researchers, teachers and energy engineers with teaching experience in higher education and public and private organisations.

All teaching and study material will be in English.

PRACTICAL DETAILS

The course is free of charge in the sense that the teaching and study material will be provided by the project.

The participant will need to make room for 5 half days in the calendar to attend the online course which will be hosted by CRES, Center for Renewable Energy Sources and Saving, which is the national agency for coordination in the fields of renewable energy and energy efficiency in Greece.

CRES is a partner in the ERASMUS+ Synergy Audit project.
