

Since the 1970s, environmental policies have been central to European politics, with efforts intensifying in the 21st century through key milestones like the 2030 Agenda, Paris Agreement, and European Green Deal. The EU also prioritizes gender equality, reflected in initiatives like the Gender Equality Strategy (2020).

Climate change policies affect citizens differently based on factors like gender and income, with women often more vulnerable due to inequalities. The European Green Deal aims to address these gaps by integrating gender equality into climate policies.

This project highlights citizens' key role in achieving environmental and gender equality goals, fostering awareness of EU policies through Town Twinning to counter euroscepticism and ensure a just transition.

The **main objective** of the project is to enhance the promotion of the European Green Deal from a gender inclusive perspective among citizens.

The specific objectives are the following:

- * To increase knowledge among citizens about the European Green Deal and its initiatives and actions;
- * To increase competences on the Gender Equality strategy 2020-2025;
- * To reflect gendered differences in environmental behaviours and attitudes;
- * To exchange best practices among European partners to create the basis for a long-lasting path of collaboration at European level on the topic with networking with local stakeholders and citizens.
